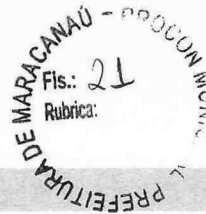

From time to time, Algar Telecom S/A (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
